(LINCOLN)-Farm Service Agency (FSA) State Executive Director Dan Steinkruger announced 89 counties in Nebraska have been designated as primary natural disaster areas due to the ongoing drought. Those counties are:

drought intensity value. “The 89 counties that received the Primary Secretarial Disaster Designation have a drought intensity value of extreme (D3) or exceptional (D4),” said Steinkruger.

At this time, there are four counties in Nebraska that have not been declared a Secretarial Disaster. These counties are contiguous to counties that have received the declaration and are also eligible for certain disaster assistance due to drought. The four counties are:

Nuckolls                  Nemaha                  Pawnee                  Richardson

This designation authorizes Emergency (EM) Loans for eligible producers. Steinkruger stated, “Producers are encouraged to contact their local FSAServiceCenter for detailed information about available programs and updated Secretarial Disaster Designations.”

In addition to the Emergency (EM) Loan Program, the FSA has other loan programs and disaster assistance programs that may assist farmers in recovering from their losses.
