(Neb.)-Chadron finishes fourth at Shatto Tournament

Willy Cogdill was the 160 pound champion and five other Cardinal wrestlers placed in the top four as Chadron finished fourth Saturday at the Shane Shatto Memorial Tournament in Douglas, Wyo.

Cogdill won a 19-16 decision over Benjamin Loya in the finals to earn first place and improve his record to 18-2 for the season.

Daniel Goings placed second at 106 lbs., Joe Ritzen was fourth at 113, Tate Cullers took fourth at 152, Cooper Cogdill finished third at 195, and Tanner Kickland got second at 220.

Chadron finished fourth in the team standings with a score of 141.5. Cheyenne East won the event with 197 points.

Chadron's next competition will be Friday when they travel to Lexington for the East-West Challenge.
